Introduction

This document contains detailed messaging specifications and samples for each of the 7 message types and 3 types of clinical records required to support the functional requirements of AMIE proof of concept. The 7 message types and 3 types of clinical records are the following:

Message Types

1. Record Locator Service Publish Request
 - o Emulator generates this type of message and sends it to record locator service to publish availability of a clinical record.
2. Record Locator Service Publish Response
 - o Record Locator Service responds with this message type to Emulator with this message type to communicate whether the publish operation successfully completed.
3. Lookup Patient Request Specification
 - o Viewer generates this message type to look for a patient in the master patient index.
4. Lookup Patient Response Specification
 - o Record locator service responds with this message type to viewer with a list of matching patient records.
5. Lookup Patient Record Request Specification
 - o Viewer generates this message type to request for a list of records available for viewing for specific patients.
6. Lookup Patient Record Response Specification
 - o Record Locator Service responds with this message type to supply viewer with a list of records available for viewing.
7. Retrieve Record Request Specification
 - o Viewer generates this type of message to retrieve a set of records

Retrieve Record Responses (Same as Clinical Records)

There are 3 types of clinical records. Below is the set of clinical records that the Emulator may return to viewer upon viewer request and availability of records.

1. Lab Result
 - a. Sonora Quest Lab Results
2. Discharge Summary,

- a. Banner Health Discharge Summary
 - b. Saint Joseph's Hospital and Medical Center (SJHMC) Discharge Summary
 - c. Maricopa Integrated Hospital System (MIHS) Discharge Summary
3. Medication History
- a. Managed Care Pharmacy Consultants (MCPC) Medication History

The message structure and the majority of the terminology and code systems were taken and/or derived from the following standards:

- HL7 Version 3 Messaging Standard implementation guide
- Clinical Document Architecture (CDA) implementation guide
- Continuity of Care Document (CCD) implementation guide

Please refer to the above documents for any code system or terminology definition not found on this specification, but part of the message specification.

Identification convention for Organizations, Gateways, and Source Systems using OIDs

Organization ID (May be assigned by HL7 upon request)

Each organization must have a unique id for their organization in the form of an OID. All data provider organizations should register an OID with HL7 for their organization. (e.g. AMIE organization OID is 1.16.840.1.113883.3.138).

Gateway ID (Assigned by AMIE)

Gateway ID will be generated and assigned by AMIE in the form of an OID. This OID will be derived from AMIE organization ID. Each new gateway ID will be derived by concatenating AMIE organization ID, number 3 and a gateway ID index. The gateway id index will be increased by 1 unit for each new gateway deployed.

Gateway ID = 2.16.840.1.113883.3.138. + 3 + {gateway id index} (e.g. Gateway ID=2.16.840.1.113883.3.138.3.1)

Source system ID (Assigned by AMIE based on Organization ID)

Source System ID will be generated and assigned by AMIE in the form of an OID. This OID will be derived from the data provider organization ID. Each new Source System ID will be derived by concatenating the data provider organization ID, number 1 and Source System ID index. The Source System id index will be increased by 1 unit for each new Source System.

Source System ID = 2.16.840.1.113883.3.154. + 1 + {Source System id index} (e.g. Source System ID=2.16.840.1.113883.3.154.1.1)
